Board of Directors Report

NALTEA held its general meeting of members on January 19, 2008 via telephone conference call. Due to an unforeseen family obligation, outgoing president Mary Mitchel was unable to attend the meeting. Then-vice president, Ed Gunther, chaired the meeting with 19 members in attendance.

The meeting began with approval of the previous meeting's minutes and a Treasurers Report presented by NALTEA treasurer, Wanda Steudel. Next, the three candidates running for two board positions, David Pelligrinelli, Ed Gunther and Debi R. Merrill, made statements prior to the balloting.

In a first for NALTEA, the election was held by electronic vote on the NALTEA website. Each member in attendance received a link to the ballot by email following the opening roll call. The ballot was accessible only to the members present at the meeting. After the candidates' statements, the members placed their votes to fill the two positions on the board of directors.

As the ballots were tallied, each committee chairperson gave an update of the committee's activities over the past year and offered plans for the current year. The floor was then open to members to voice concerns and opinions. There were no comments from the members.

Doug Gallant, chairman of the Publications and Benefits Committee, and operator of the electronic balloting, announced a single board seat winner, Ed Gunther, and a tie between Pelligrinelli and Merrill for the remaining seat. As Gallant and Source of Title's Slade Smith (who

graciously volunteered to act as our technical consultant for the electronic balloting) began to prepare the ballot for a runoff, a concern was raised that at least one voting member had already left the meeting. After a short discussion to resolve the issue, Debi Merrill withdrew her candidacy. This selfless act effectively ended the tie and David Pelligrinelli was declared the winner of the board position.

With the new board of directors in place, the next order of business was to assign chairpersons to each committee. The committee assignments are:

The meeting closed with statements from board members thanking outgoing president, Mary Mitchel, and former board member, Jay Duncan, for their years of dedicated service to NALTEA.

The new board of directors met in a separate conference call immediately after the general meeting concluded. The purpose of the second meeting was to appoint officers for 2009. The following appointments were made by unanimous vote of the board members:
